Andrade, Claudia, RN75976: Agreement for Probation for a term of 5 years for NRS 632.347 (1)(g) unprofessional conduct, NAC 632.890 (9) impaired practice, (27) customary standards of practice, and (39) pattern of conduct demonstrates failure to protect public.

Becker, Karen, LPN 851994: Agreement for Reprimand and Continuing Education for NRS 632.347 (1)(g) unprofessional conduct, NAC 632.890 (20) inaccurate recording, falsifying or otherwise destroying records.
